**NOTICE OF FILING DEADLINES AND SCHEDULE FOR STATUS CONFERENCE  
AND EVIDENTIARY HEARING**

The Bondholder Committee should file its proposal by April 24, 2007. The Receiver should file any amendments to his proposal and/or response to the Bondholder Committee proposal by May 4, 2007. The Bondholder's Committee has until May 14, 2007 to file a reply to proposal. A status conference to discuss the form of Notice to be issued to the investors is set for **Wednesday, May 9, 2007 at 10:00 a.m. in Room 307 of the United States Courthouse, Indianapolis, Indiana.** An Evidentiary Hearing on the proposals is set for **Monday, July 16, 2007 at 9:00 a.m. in Room 307 of the United States Courthouse, Indianapolis, Indiana.**

By May 9, 2007, the Receiver and Bondholder's Committee shall agree to a briefing schedule leading up to the evidentiary hearing, including, dates for stipulations and the identification of witnesses and exhibits. If an agreed schedule cannot be

reached, counsel will meet with the Magistrate Judge following the status conference on May 9<sup>th</sup> so that the Magistrate Judge can impose a suitable schedule.

The Receiver's request for time to response to Motion to Intervene filed by Dr. Brent Dove is **GRANTED**. The Receiver has until May 8, 2007 to respond to the Motion to Intervene. Counsel for Dr. Dove has until May 22, 2007 to file a reply.
